



Customers Data Privacy Notice

What information is being collected?

The information we are collecting includes:

- Name
- Address including postcode
- Email
- Phone number (if provided)
- Product being bought.

Who is collecting it?

AFC Unity are collecting and processing this information when orders are made via PayPal, in person or by bank transfer.

Teemill are collecting and processing this information when orders are made via Teemill.

How is it collected?

This data is collected electronically, with customers purchasing AFC Unity merchandise online via PayPal, enabling us to post the merchandise to the customers. Merchandise can also be purchased electronically by bank transfer.

Merchandise can also be purchased in person, paying in cash or via iZettle.

If customers purchase merchandise via Teemill, we do not collect or process any data other than a record of products sold with this not providing any information regarding the customer who purchased the product. Teemill process the order, including sending out the product to the customer.

How will it be used?

We collect and process this data for several reasons, including:

Retention Period

We will keep receipts and invoices for our accounts, which we need to maintain a record of legally, for 7 years. This will include storing data on our electronic accounting system, Quickbooks, as well as having paper copies.
